ARTICLE-1

ARTICLE-2

SCOPE OF CO-OPERATION

The Parties agree to implement cooperation programs including but not limited to:


- a. Exchange on best practices

ARTICLE-4

EXECUTING AGENCY

To implement this MoU:

- 1. JCC appoints the Principal, Jamshedpur Co-operative College, Jamshedpur
- 2. Arka Jain University, Jamshedpur appoints the Registrar, Arka Jain University, Jamshedpur

ARTICLE-5

FINANCIAL ARRANGEMENT

- Any co-operation under this MoU is subject to the availability of funding sources and approval by relevant authorities.
- Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

ARTICLE-6

INTELLECTUAL PROPERTY RIGHTS

- Each Party shall protect, within its territory, intellectual property rights of the other party in accordance with the domestic law in force in this respective countries.
- 2. In case of specific arrangement, programs or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with their respective laws and regulations.

ARTICLE-7

AMENDMENT

- 1. This MoU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MoU.
- 2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

Based on the principles of equality, reciprocity, and mutual benefit, Jamshedpur Co-operative College, Jamshedpur (Kolhan University, Chaibasa) and Arka Jain University, Jamshedpur hereby agree to explore the following avenues of educational exchange:

- 1. Student exchange program.
- 2. Curriculum development and Offering specially designed programs of study.
- 3. Collaborative Research projects.



- 4. Promoting and encouraging joint research projects and other scholarly co-operation, particularly on Sustainable Development, Tribal Studies, Linguistics, Medicinal Plants, Environment and other areas as decided from time to time.
- 5. Development of research/academic activities in key areas.
- 6. Initiating activities to run innovative interdisciplinary courses.
- 7. Events collaboration to accelerate entrepreneurship and innovation.
- 8. Joint Incubation Program.
- 9. Conducting workshop and training to students and faculty.
- 10. Academic leadership & Innovation.
- 11. Pursuing other mutually advantageous undertakings.

Both the universities agree to the above in principle, subject to the completion of such other formalities required by the university bodies including the approval of the competent Authority.
